Have you been a victim of medical malpractice?

"People should be aware that medical complications resulting from treatment may or may not be caused by malpractice. Patients have the right to question the cause of their injuries," said Clifford Zelen, Managing Partner at the law firm of Ross, Legan, Rosenberg, Zelen & Flaks LLP.

Medical malpractice often can have disastrous or fatal results because of the failure of the physician or health care provider to provide the proper, expected care. • Anesthesia. If you have a surgical procedure of any sort, you most likely will be administered anesthesia. It is the responsi-

The improper administration of anesthesia can result in brain damage or even death.

- Birth complications. Many preventable complications can occur during the labor and delivery process. The doctor is supposed to monitor the infant's oxygen supply during delivery. Too little oxygen can result in cerebral palsy. Erb's/Brachial Plexus Palsy also is a preventable trauma injury to the nerves that can leave a child with a permanent shoulder or arm nerve injury. The trauma can occur by a doctor miscalculating the force necessary during delivery.
- Hospital errors. During a stay in a hospital, you come into contact with a host of people, including doctors, interns, nurses and medical technicians, who provide some level of care for you. However, no one is perfect and mistakes can be made during your treatment.
- Medical misdiagnosis. People trust a physician to give everyone the best possible care available. Doctors see dozens of patients a day and sometimes they get it wrong when it comes to the correct diagnosis. These misdiagnoses may cause additional medical problems, injuries or even death. Common diseases that are frequently misdiagnosed include cancer, strokes, heart attacks, pulmonary embolism, appendicitis
- Medication errors. It's an old joke about a physician's poor handwriting, but it's no joke when it comes to taking the wrong medicine. The wrong medication could be administered due to poor handwriting or the medication may be inappropriate for a specific patient based on his or her current ailments.

and intestinal obstructions.

- Physician malpractice happens more often that admitted. Besides misdiagnoses, medical errors by a physician include surgical complications, failure to refer to a specialist or failure to order the appropriate diagnostic tests.
- Wrongful death. It's not something anyone wants to think about, but studies show that thousands of people die every year in the United States due to medical or hospital errors. Wrongful death from medical malpractice may be caused by surgical, medication,



anesthesia or diagnostic errors. Wrongful death claims may be sought by family members who have suffered a significant financial loss because of a death.

These are just a few of the common medical malpractice examples. Unfortunately, medical malpractice can occur in any health field, from pediatrics to surgery. Also, keep in mind that some medical malpractice traumas do not show up until later, such as infant development delays that may occur after a difficult delivery.

Major awards secured

Ross, Legan, Rosenberg, Zelen & Flaks secured a number of large awards recently, including:

- \$2,640,000 for a victim who suffered brain damage due to a defective defibrillator that caused a delay in resuscitation efforts.
- \$2,600,000 for a woman who suffered an anesthesia complication that resulted in brain damage during a gynecological procedure.
- \$1,500,000 for an infant who was injured during the birth process.
- \$1,200,000 in a malpractice suit for a woman whose cancer went undiagnosed.

- \$1,200,000 for a demolition worker who required shoulder surgery after suffering a work-related accident.
- \$750,000 for a teacher who fell in school. This was one of the top 10 settlements against the City of New York in 2007.
- \$500,000 jury verdict award for an airport maintenance man who tripped in a hole on a runway, damaged his knee and required surgery.
- \$199,000 settlement after a jury liability verdict for a bicycle courier, despite the testimony of a neutral witness who testified that the bicyclist fell in front of the defendant's truck.
